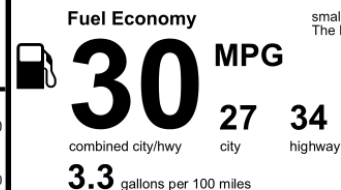

Gasoline Vehicle



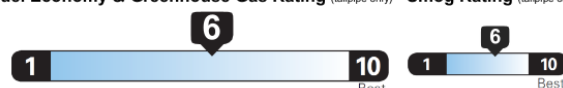
